REFUND POLICY AND PAYMENT PLAN

Your child has been selected to participate with the Illinois Raptors or Illinois Lady Raptors Traveling Basketball Team, a program offered by the Mills Athletic Council (MAC), which qualifies you to participate in The MAC's payment plan.

PAYABLE TO THE MAC

- Total fee's are \$700
- The non-refundable deposit of \$400 is due immediately upon acceptance of roster spot, this is the first installment.
- The Final installment of \$300 is due no later than April 16th, 2010

▶ Note all payments need to be made prior to the start of practices and games to be eligible to participate!

The Illinois Raptors basketball program is facilitated through The MAC, a not for profit organization. Timely Tuition payments are necessary to provide the services described in this program. Accordingly, The MAC reserves the right to cancel, withdraw or withhold players from actively participating in Illinois Raptors programs, including but not limited to games, tournaments, and practices, for non payment of Tuition. All Tuition payments are due as indicated in the Payment Plan. No team uniform package will be given to any player that has not fully satisfied his/her Tuition payments. There will not be any exceptions.

Check Policy

The MAC welcomes your personal check but in the event that your check is return for any reason by your bank there will be a \$25.00 return check fee accessed.

Refund Policy

The first installments of \$400 is non-refundable and absolutely No refunds will be given once the programs begins.

PARTICIPANT AGREEMENT, hereinafter the "Agreement"

I. WARNING OF RISK.

As a parent/guardian of a participant in the program, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, including death, damages or loss which I or my minor child may sustain as a result of participating in any and all activities connected with or associated with such a program. I agree to waive and relinquish all claims I or my minor child may have as a result of participating in the program against Illinois Raptors Basketball, Mills Athletic Council and its coaches, board members, and volunteers.

II. WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK.

I acknowledge and assume the risks of property damage, accidents, injuries (including death), loss of bodily functions, disabilities, medical disorders, pain and suffering, lost income and medical expenses that arise from the participation the program. In consideration of being allowed to participate in the program offered by the Mills Athletic Council (MAC), I hereby waive and discharge The MAC and its officers, officials, agents, volunteers (collectively, the "Releases") from any and all liability and all claims of any kind whatsoever for personal injury, property damage or death, arising from participation in any activity or program offered by The MAC, whether or not caused by negligence of the Releases or any of them and further covenant that I shall not sue any of the Releases with respect to any such liability or claims. In the event that I or anyone else nonetheless makes a claim or files suit against Releases arising out of the above described matters, I will indemnify and hold harmless of and from any and all damages or judgments and costs of litigation, including attorney's fees. This Agreement shall be governed under the laws of the state of Illinois.

III. PROGRAM MEDIA

As a parent/guardian of a participant, I understand that photographs, video recording and other print media (hereinafter, Program Media) are collected throughout the season. I further understand that all Program Media will be deemed property of The MAC to use for future advertisement and promotion of the program.
